- Tom Quinn, Senior Director, Sales for USA Funds has resigned to take the position of Senior Vice President, Sales for Academic Management Services (AMS).




- **Gail V. Ferreira** has been promoted to District Vice President of the Midwest Region for AMS.


RETIREMENTS


Kathleen pointed out that there was an effort made to include Proprietary interests on the agenda.


Winter Site Committee

Budget was designed based on history of previous conferences as well as the current costs give by Westin Hotel. Training Committee

Two trainers have been identified to travel to Washington, D. C. to be trained on the NASFAA topics for the fall training. The topics are Treatment of Resources and Packaging Considerations. Peg Creech, lvy Tech-Bloomington and Debra Wilson, Purdue University will be in Washington on September 22 & 23 for the train-the-trainer sessions.

Christina Coon, Training Committee Chair has contacted several places to hold the training sessions. The Executive Committee approved the Sallie Mae location in Fishers, Indiana as their first choice for the session. This facility is available at no cost to ISFAA and can seat approximately 100 people.

Christina had also worked with a variety of dates on which to hold the training. The Executive Committee settled on November 18, 2002.

The Executive Committee discussed the costs of the NASFAA training sessions. ISFAA strives to keep the costs minimal for the membership; however, the cost of providing the sessions must be covered. It was suggested that there be a \$65 charge for the session with materials and a \$25 charge without materials. Jeff Pethick motioned to accept this fee. Doug Irvine seconded. Motion carried. Registration fee for the Fall 2002 NASFAA Workshop will be as such.

Discussion was held regarding the Spring 2003 NASFAA Workshop. Trainers will need to be identified. The train-the-trainers session will be held in January 2003 in Washington, D.C.

The committee is still reviewing possible locations for future conferences. At this time, it appears that The Falls of the Ohio in the Clarksville, Indiana area would be a possible site.

Long-Range Planning Committee


Marvin Smith, Chair, has been reviewing the NASFAA Strategic Long Range Plan for 2001-2006. By the next Executive Committee meeting, which will be in November, Marvin would like to form a "planning team."

Sponsorship

Raina Chezem, Chair, mailed out 33 sponsorship contracts at the end of July. Requested deadline for return contracts set for September 27, 2002.

Winter 2002 conference currently has 12 exhibitors (\$3900) and \$5387.50 in sponsorship. Last year, the final count was 27 exhibitors (\$7425) and \$8615 in sponsorship. It is anticipated that there will be approximately 27 exhibitors at the Winter 2002 conference.

Spring 2003 conference also has 12 (\$3900) exhibitors and \$5262.50 in sponsorship currently. Last year, the final count was 23 exhibitors (\$6323) and \$7315 in sponsorship. The number of exhibitors was down slightly due to the Illinois conference being held at the same time of the Indiana conference.

NEW STATE FAFSA FILING DEADLINE FOR 2003-04

As a reminder, SSACI has changed both the criterion and the date for a student to be considered an "on-time FAFSA filer". Effective for the 2002-03 financial aid year, the requirement is that the FAFSA be received by the federal government on or before March Tenth (10th). The date a student mailed the FAFSA is irrelevant. All that matters is when the FAFSA is received. SSACI has gone to a receipt date to bring consistency to online versus paper FAFSA filing. In the past, online FAFSAs had to be completed with the processor by March I whereas paper FAFSA filers were allowed "travel time" as long as their FAFSAs were postmarked by March I. But it's no longer about postmark date, now it's about receipt date. And that date is March 10, 2003 for the 2003-04 academic year.

Think and promote receipt date. This is analogous to paying bills by the due date. There is no more postmark date. There will be no "travel time" as there has been in the past. There will be no expectation that students obtain a certificate of mailing. However students should still complete and submit the postcard included with the FAFSA in the event a receipt date is ever questioned. If self-addressed and postage paid by the applicant, the postcard will be stamped by the CPS with the application receipt date and mailed back to the applicant. Using a receipt date makes sense for a process that can be done instantaneously online because it gives students more time to file FAFSAs.

That said we encourage you to encourage students to get PINs and file online particularly if filing close to SSACI's March 10 receipt deadline. Studentswho file via mail assume the risk of calculating the time it will take to get the FAFSA to the CPS so that it is received by March 10, 2003. However if a student files online on March 10 they will be considered as having filed on time. Also, generally online filers make fewer FAFSA errors thus lowering their odds of being disqualified for state aid due to errors.

SSACI knows this is a big change. We are working with the U.S. Department of Education to make the needed changes on the paper and on-line FAFSA. At a minimum, the state deadline will say, "March I date received (no longer date postmarked)". It will not have the little ^ which footnotes: "Applicants strongly encouraged to obtain proof of mailing." Proof of mailing no longer matters.

In addition, we have sent a notice to all high school Directors of Guidance. We are sending notices to CounselorTalk, the closest thing the counseling community has to a listserv. The information will be posted on the SSACI web site. All email inquiries receive a response noting the 2003-04 FAFSA receipt deadline. ICPAC has the information in their publications. We are exploring sending email notices and postcards to all potential returning students. But we also need your help.

We encourage our college colleagues to tell students about the change through such media as broadcast email, voice mail, notices in student publications, and bulletin boards throughout campus, comments on second semester bills, and any other means that are routinely used to let students know about important deadlines. Whether it's a postmark date or receipt date, students do appeal. Be assured that SSACI will continue to seriously consider each case and make a decision. But be also assured that it is not SSACI's responsibility to second-guess why the FAFSA was not received on time, whether completed online or on paper.

SSACI strongly believes this is the best course for students and is committed to the receipt date concept. Indeed, it is likely this change will increase the number of on-time filers. We will do all we can to get the word out about the change but we do need your help. Feel free to go to our web site http://www.in.gov/ssaci/workshop/, download Item 6, the "March 10 FAFSA Flyer", and customize it for distribution to your students. If you have questions, comments or concerns, please let me know. The SSACI staff and I look forward to working with the financial aid community to ensure that this transition to receipt date goes well for Indiana students.

Washington, D.C. (October 11, 2002) – NASFAA's 2002 Fall Training Series, which focuses on *Treatment of Resources and Packaging Considerations*, began the first week of October and continues through the end of the year in many states and regions throughout the country.

Treatment of Resources and Packaging Considerations examines the challenges institutions face when awarding and disbursing non-Title IV and Title IV resources. The training materials are designed to help financial aid administrators answer many of the questions surrounding the administration of student financial aid funds. The workshop is structured to:

 Clarify the usage of statutory, regulatory, and IRS terminology when identifying different resources;

- Examine operational strategies when packaging non-Title IV resources;
- Identify compliance issues when packaging non-Title IV and Title IV resources;
- Discuss strategies for resolving potential overawards; and
- Discuss communication between the financial aid office and academic departments and the business office.

Most state and regional associations sponsor a NASFAA workshop, which means that the states and regions select the workshop locations, dates, and instructors, and coordinate the registration activities. ISFAA REACHES OUT TO ASSIST FAMILIES DURING FEBRUARY

February is Financial Aid Awareness Month (FAAM) and plans are under way to involve the financial aid community in helping students and parents get answers to their financial aid questions. ISFAA links with the ICPAC Hotline to provide a unique service for Indiana residents. Through a toll-free call (I-800-992-2076) or e-mail (http://icpac.indiana.edu/utils/Contact.cgi), families can get answers to basic financial aid questions and help in navigating more complex issues.

Each ISFAA member institution identifies one of its staff members to serve as a resource representative for the FAAM Hotline. This professional provides the ICPAC Hotline with his/her phone number and e-mail address. Throughout the month, the Hotline Information Specialists respond to calls and answer basic financial aid questions. If a caller has a unique situation or one that goes beyond the expertise of the Hotline, the Information Specialist asks what school the student is planning to attend and directs the caller to that school's FA Resource Representative. If that person is unavailable, the

Hotline staff member will assist the caller in leaving a voice mail message or will send an email to the designated ISFAA member. Direct numbers and email addresses are not shared with the caller.

Steve Meek, Director of the ICPAC Hotline, will be contacting member institutions soon to solicit help in identifying their "Resource Representative". The most common question, asked of the ISFAA Media Committee in the past, is "How many calls will I receive?" The number varies across institutions, but no school typically receives more than 20 during the entire month. Some schools may receive one call while others may receive more.

Why is this an important service? Many parents and students turn to the ICPAC Hotline for help. This collaborative service directs families to the right place for the best information and answers. The school the student is planning to attend best addresses professional judgment issues and institutional policies. This process ensures families get to the right place for advice. Getting the best help and information to Indiana families is the goal of Financial Aid Awareness Month.

College Goal Sunday 2003: Feb. 9, 2003 from 2-4 p.m.

College Goal Sunday 2003 is fast approaching. Continually working to expand College Goal Sunday's impact, the committee has been busy improving two of the outreach methods.

ISFAA FINANCIAL AID NIGHTS

As 2003 begins, ISFAA will once again be offering our financial aid knowledge assisting senior high school students and their families as they prepare for the first year of college. Many of you have already been contacted by a regional coordinator to present a financial aid session at a high school in your area.

As a presenter, please remember that your presentation is on the behalf of ISFAA rather than your respective institutions. There is a PowerPoint presentation on the NASFAA website at www.nasfaa.org/subhomes/financialaidnight/FAnight.asp that can be used for your presentations. After your high school session, please contact the regional coordinator to report the number of individuals who attended the session as well as your total miles traveled.

The evaluation form, to be completed by the high school guidance counselor, is now available for completion and submission via the ISFAA website at http://www.isfaa.org/forms/FANightEvaluation.htm.

As financial aid professionals, we all realize the significance financial assistance plays in the pursuit of a post-secondary education. The partnership between ISFAA and the guidance counselors is essential in order to attain this goal.

HINTS FOR YOUR FINANCIAL AID NIGHT Before the Presentation

Contact the guidance counselor before the session in order to determine the type of presentation they expect. Some schools will want a thorough review of the entire FAFSA line by line, while others may require only general financial aid information.

If you will need specific equipment for the presentation, notify the counselor well in advance so that it can be requested.

Ask the counselor if the school has received the 2003-2004 FAFSAs or FAFSA on the Web instructions. If not, you will need to bring a supply.

During the Presentation

Remember that you presentation is an ISFAA effort rather than one for you individual institution. They may be opportunities to use your school as an example but remember we are not promoting our individual institutions.

Encourage families to attend College Goal Sunday, February 9, 2003, if they would like assistance completing their FAFSA form.

Limit the use of financial aid lingo such as SSACI, SEOG, CPS, etc. These words have the tendency to alienate and confuse your audience.

Remind the audience of the Financial Aid Hotline available throughout the month of February.

After the Presentation

Give the high school counselor an evaluation form or ask them to go on-line to fill out the evaluation.

GEARING UP FOR THE 2003 FAFSA: ASSISTING STUDENTS AND THEIR FAMILIES FOR THE COMING YEAR

Every financial aid officer knows one of the bigger challenges each year is helping new students and their families complete the FAFSA for the first time. Although most of us in the financial aid community know that the FAFSA as been simplified considerably from years past, many students and their parents are still intimidated by the process. Most of them seek additional help, and are most comfortable when they are guided step-by-step.

Here are some useful tips to help students and their parents accurately complete the FAFSA:

- Remind and encourage students and their families to use FAFSA on the Web if possible. Logic checks and other features in the web interface reduce the possibility of errors.
- Emphasize how to distinguish the current form from previous forms. Make sure students and families understand which form is appropriate for the current year.
- Emphasize the importance of keeping copies of the FAFSA and all future correspondence.
- Prepare a one-page reference sheet for families and students, listing deadlines, important web sites, phone numbers, and relevant sources of information.
- Host an evening event when counselors, families, and students can come together and learn about finalizing tasks in high school, preparing the FAFSA, and exploring postsecondary education opportunities.

To assist students and their families in overcoming their apprehension about the FAFSA, TG, in collaboration with financial aid administrators, school counselors, librarians, and other community-based organizations, offer a program entitled "Applying for Financial Aid: The FAFSA Process." Available at no cost in both English and Spanish, the teleconference program provides an effective way to deliver important information to students and their families in completing this critical step to realizing their educational and career dreams. This year the TG Teleconference will take place on Thursday, February 6, 2003.

The program is offered in two formats: as a satellite teleconference broadcast for host sites that are able to receive such signals, and as a videotape for sites with no satellite reception capabilities. Host sites receive several useful tools to organize and promote their local events, including posters, fact sheets, and a press kit—all free of charge. In addition, host sites are listed in a directory on Adventures In Education, TG's public awareness web site located at www.AdventuresInEducation.org.

USA Funds Cuts Annual Default Rate to Below two Percent



USA Funds® has cut its annual default rate to below 2 percent. For the year ending Sept. 30, 2002, USA Funds posted an annual default rate of 1.97 percent, a significant reduction from the previous year's default rate of 2.51 percent. USA Funds has cut its annual default rate by more than half since 1998.

The annual default rate compares the dollars in default on loans guaranteed by USA Funds against the dollar value of all USA Funds-guaranteed loans in repayment. This default rate often is called the "trigger" default rate, because higher default rates trigger lower federal reimbursement to a guarantor. The decline in the annual default rate reflected the results of several USA Funds initiatives, including the following items:

Promoting successful repayment. USA Funds offers
postsecondary institutions the leading online entranceand exit-counseling services for borrowers. In addition,
the guarantor supports a wealth of online and print
information to keep borrowers on the path to
successful repayment.

- Massive default-prevention campaign. Under a performance-based agreement with its guarantor-servicer, USA Funds contracts for a team of 200 full-time specialists, backed by the latest technology, who work with borrowers who have fallen 60 days or more behind in their loan payments. These representatives make more than 20 million telephone attempts annually to contact borrowers and counsel them about the options for resolving their loan delinquency. As a result of this massive effort, USA Funds averts default on nearly 93 percent of past-due accounts on which lenders have requested the guarantor's assistance. During fiscal 2002, USA Funds prevented approximately \$10.7 billion in loan defaults.
- USA Funds' debt-management initiative. USA Funds offers schools a team of seven debt-management consultants who conduct free workshops and one-on-one consultations to help schools enhance their default-prevention efforts. USA Funds also convenes a Default-Prevention Council, which develops and disseminates tools to help postsecondary institutions reduce their default rates. Among the fruits of the council's work are USA Funds' financial-literacy program, Life SkillsSM, and an online Best Practices Manual, which provides tools and resources to enhance campus default-prevention efforts.




