### Indiana's Statewide FAFSA Completion Goal



#### INDIANA COMMISSION for HIGHER EDUCATION

The Indiana Commission for Higher Education (Commission) has set its statewide Free Application for Federal Student Aid (FAFSA) completion goal for high school seniors to improve FAFSA filing rates, which will increase student access to state, federal and institutional financial aid.

The Commission's goal is for at least 60 percent of the high school graduating class of 2024 to complete the FAFSA by the state's April 15, priority deadline. This will position Indiana to be in top 10 for FAFSA completions nationally from high school seniors.

Filing the FAFSA is the first step toward accessing some of the over \$400 million in state financial aid and billions of dollars in federal aid. According to the <u>National College</u> <u>Attainment Network (NCAN)</u>, Indiana high school graduates left roughly \$70 million in Pell Grants on the table in 2022 by not completing the FAFSA.

This year, the 2024-2025 FAFSA will be released by the U.S. Department of Education in December. Once available, the Commission will launch its interactive online dashboard to track progress toward the 60 percent goal. The dashboard can be filtered by county, school and 21st Century Scholars, allowing partners to monitor progress.

Also, new this year is the requirement for high school seniors to file the FAFSA unless the student opts out or is opted out. Students who do not wish to file may opt out in the following ways:

- a parent of the student submits a FAFSA Waiver Form certifying the student understands what the FAFSA is and declines to complete it;
- **the student**, if the student is an emancipated minor or is at least 18 years old, submits a signed waiver certifying the student understands what the FAFSA is and declines to complete it; or
- the high school principal or counselor of the student waives the requirement due to not being able to reach the family of the student by April 15 after at least two reasonable attempts.

The FAFSA Waiver Form will be released on annual basis on the opening day of the FAFSA. However, the Commission will release this year's waiver early due to the 2024-2025 FAFSA opening in December. The FAFSA Waiver Form will be made available later this month.

Students and parents can get a head start on filing by creating Federal Student Aid IDs (FSA IDs). A legal guardian of a student does not need to create an FSA ID – a parent is only required for dependent students. Visit www.FAFSA.gov to get started.

Students and families can contact the Commission's <u>outreach coordinators</u> to access free FAFSA-filing assistance.

#### 1. Please tell Bits and Bytes about your current position at Indiana Tech

I worked multiple times with a student over many years that wasn't always pleasant. He was not very savory to most people in our office either. We finally had a longer meeting a couple years in. We discussed his family life, and I realized the burden he was carrying by not sharing it earlier. We were able to work through the issues we could resolve with his financial aid. I kept reassuring people in my office that he was a good kid, just going through stuff. He stopped in about a week before graduation and threw a card on my desk and said 'here' and then he left. In the card he said he knew he could not have graduated without me and appreciated everything. You never know who needs your help the most and how compassion may make a world of difference.

### 5. Please tell us about any other leadership roles you've had involving financial aid

I've had quite a few leadership roles at Indiana Tech and have been on previous boards, but this is my first leadership position in financial aid.

# 6. You joined ISFAA in 2012. Please share your thoughts about the organization after 11 years as a member...

I think it's a great group of dedicated professionals. While I've been a member for years, I didn't become involved until recently. I thought other people just has everything taken care of and didn't need my help. The same people are involved in ISFAA because it takes a lot of work to best serve students, elevate the perception of this profession, and keep an organization running.
